International Profile and Mandate of the Nalanda University

Established under the Nalanda University Act, 2010 (No. 39 of 2010) by Government of India, the standalone University in India is mandated to be an international institution, as cherished by the eighteen East Asian countries - India, Australia, Bangladesh, Bhutan, Brunei Darussalam, Cambodia, China, Indonesia, Laos- PDR, Mauritius, Myanmar, New Zealand, South Korea, Sri Lanka, Thailand, Portugal, Vietnam and Singapore in the Second East Asia Summit, at Philippines (January, 2007), and values echoed in the fourth East Asia Summit at Thailand (October, 2009) on the glorious heritage of the ancient Nalanda University in Bihar, which from 5th to 12th CE for eight centuries was the undisputed educational hub & leader in then existing all the branches of pedagogy across the world. The visualised vision & mission of the leaders were the following.

➤ To strengthen regional educational co-operation by tapping the East Asia Region's centers of excellence in education and for the revival of the Nālandā University in the State of Bihar to improve regional Understanding and the appreciation of one another's heritage and history;

(2nd East Asia Summit)

➤ To encouraged the networking and collaboration between the Nalanda University and existing centres of excellence in the East Asia Summit so as to build a community of learning where students, scholars, researchers and academicians can work together symbolizing the spirituality that unites all mankind;

(4th East Asia Summit)

➤ To carry out higher studies in the subject areas that can promote peace, support and sustainable development.



- 2) To contribute to the promotion of regional peace and vision by bringing together the future leaders of the East Asia, who by relating to their past history can enhance their understanding of each other's perspectives and to share that understanding globally;

- 3) To harmonize the academic standards and accreditation norms in teaching, research and curriculum that are acceptable to all Member States;
- 4) To create a unique partnership between the scholars and interested persons from the Member States;
- 5) To understand the Buddha's teaching in the contemporary context without excluding any other thoughts and practices from any other part of the world;
- 6) To enhance research for greater interaction between Asian countries, particularly between East Asia, bound by strong historical commonalities in areas like trade, science, mathematics, astronomy, religion, philosophy and cross- cultural currents;
- 7) To foster in the students and scholars the spirit of accommodation, understanding and thus to train them to become exemplary citizens of democratic societies;
- 8) To contribute to the improvement of the educational system of the Member States in view of the teaching in Nalanda several centuries ago;
- 9) To provide education and training in various arts, crafts and skills of the Member States, raising their quality and improving their availability to the people.
